# Understanding Real Estate Agents vs. Brokers vs. Realtors

The statute requires the policy to identify and describe the "... relationships in which such a broker may engage with any seller, landlord, buyer, or tenant as part of any real estate brokerage activities." The Real Estate Commission has not elaborated on the statutory mandate through rules or a published Commission position.

#### **Agency Policy and Broker Documents - Colorado Attorneys**

A broker associate is a real estate broker who works for another real estate broker or for a brokerage firm. Although brokers could work for themselves, many choose to join a larger real estate network. Some pay a flat fee to the employing broker and some earn a percentage of each transaction.

## Difference Between a Real Estate Broker and an Agent

The broker must be very clear as to the requirements that will apply when a licensee sells, purchases or leases out personally owned real property as both broker policy and jurisdiction regulations must be followed. This includes any fee or commission that must be paid to the brokerage.
